ANNOUNCEMENT OF INTENT TO RAISE PROPERTY TAXES FOR THE DISTRICT.

Chair Young stated the cemetery district intends to raise property tax collected on an annual basis from \$24,000 per year to \$60,000 per year. The purpose of the increase is to pay for infrastructure work in the old section of the grounds as well as in the new sections that are being developed. Equipment is needed and will be purchased when possible.

A public hearing will be held on Thursday, November 19th at 7:00 P.M. for the public to include their input.

A vote will not be taken on the proposal until Thursday, December 10th at the regular board meeting starting at 7:00 P.M.
