 - c. Project Experience Briefly describe or list projects executed by your firm that demonstrate relevant experience in desired areas of service.
 - Must list at least 10 similar projects in the past 5 years
 - d. Experience and qualifications on managing and administering federal and state grants or loan programs.
 - Demonstrate experience with the US Bureau of Reclamation and the USDA-Natural Resource Conservation Service
 - e. References Provide at least 3 references including name, address and phone number from current or ongoing projects similar to those identified above, or projects completed within the last five years.
